Treasurer's Annual Report

Dear Members,

It gives me great pleasure to present the Annual Report for the financial year concluding with Otterburn 43, 2024. I am delighted to confirm that the Society remains in a sound and highly satisfactory financial position.

Financial Performance Overview

As is customary, the vast majority of expenditure relates to our annual conference. These costs encompass logistics, refreshments, and the inevitable expenses that arise when the membership is gathered together in high spirits for a November weekend.

This year, overall conference costs were lower than anticipated, largely due to the regrettable (yet financially convenient) loss of several receipts during the traditional Sunday-morning audit at The Grosvenor Hotel. Certain expenses, specifically those relating to certain evening sandwiches, and the Tank Museum, did not appear in the accounts. As the accounts had already been finalised and published a mere seven days after Otterburn 43, it was not possible to revise them, and the amounts were accordingly written off.

Income and Reserves

The Society's reserves have grown to the enviable total of £12,00 representing an extraordinary 432% increase on the previous year. This reflects strong financial discipline, timely reporting, and the admirable ability of the Society to operate on the very frontier of accounting minimalism.

Subscription income was lower than in previous years due to each member settling his own account directly with the Grosvenor Hotel. While this reduced centralised revenue, it streamlined administration considerably.

Expenditure Breakdown

- Friday Pizza Supper: Delivery, consumption levels, and cost were all precisely in line with long-standing expectations. Pizza continues to be one of the Society's most stable and predictable budget items.
- Soup & Sandwiches: Expenditure rose modestly, due primarily to enthusiastic participation at The Mitre. The lunch featuring excellent sandwiches preceded by generous measures of mulled wine, was universally praised and deemed excellent value.

- Toggies: Costs increased marginally, reflecting ongoing commitment to maintaining the highest standards at Otterburn Conferences.

Additionally, members enjoyed a splendid dinner at the Grosvenor, which was delivered to the usual high standard and priced entirely within the expected range. It was widely agreed that the quality of the food and the warmth of the hospitality represented first-class value for money.

Conclusion

Despite minor challenges relating to misplaced receipts and the occasional enthusiastic expenditure on sandwiches, the Society concludes the year in a relatively strong financial position. Results are considered highly satisfactory, reflecting prudent management and the continued capacity of the membership to enjoy itself without endangering the Society's solvency.

It remains an honour to step aside as Treasurer, and hand over the reins of responsible financial stewardship, and, of course, excellent sandwiches to another.

Secretary's Report

Dear Members,

It is my pleasure to again present the Annual Report of the Secretary of the Otterburn Society. As you know, the principal responsibility of the Secretariat is the publication of the *Journal of the Otterburn Society*, traditionally released in June and eagerly awaited by those with the patience, fortitude, and refined literary taste required to enjoy its pages.

I must, however, address the obvious question: *Where was this year's Journal?* While some uncharitable observers may call it "missing," "overlooked," or "not remotely attempted," I prefer to view it as "strategically deferred."

The Treasurer will no doubt confirm that persuading members to submit articles on any subject, even the broadest conceivable subject, remains one of the Society's greatest challenges. History has shown that, with the sole exception of Milk Quotas, there is a near-total reluctance to commit pen to paper. As always, members would have gladly devoured Andy's contribution, for it continues to be the backbone, highlight, and in several years literally the *entirety* of the Journal.

This year, however, a variety of unforeseen circumstances hindered even the process of requesting submissions. Among the obstacles encountered were:

- A scheduling misalignment: June arrived much earlier than anticipated.
- Administrative prudence: It was deemed inadvisable to solicit contributions until the Treasurer could be protected from the emotional toll of receiving only one email.
- Technical challenges: The Secretariat's request list was accidentally filed under "next year's problems."
- Member welfare considerations: It was felt that the membership needed a sabbatical year to recharge their creative energies, gather anecdotes, and misplace receipts.

For these reasons, and in the spirit of maintaining the highest standards of editorial excellence, the Journal was *not* published this year.

Looking Ahead

I am, however, delighted to assure members that a Journal *will* be published next year. To achieve this ambitious and unprecedented target, I respectfully request that members begin preparing their contributions now. Any topic will be welcome,

historical, scientific, autobiographical, culinary, philosophical, or indeed entirely incomprehensible. Even better if it's about milk.

Submissions made early (or at least before June 30th) will be greeted with extraordinary gratitude and near-canonical reverence within the Secretariat.

In closing, I thank all members for their continued enthusiasm, good humour, and tolerance of the secretarial process. I look forward to a vigorous year of correspondence, cajoling, and, I hope, a bumper volume of the *Journal* in June.
